## Airport Update

# **Taxiway A Rehab Construction Update**

Russ Holliday with Avcon addressed the Board and presented them with the Taxiway Alpha Rehab update. Holliday explained Taxiway A procurement process was still underway. Holliday stated that Dickerson was not ready to start the project now. Holliday explained supply of material was still a concern for the project. Holliday stated the project was fully funded by FAA. Cobb asked if there was a time frame on the funding. Holliday replied three years.

### **AWOS II Construction Update**

Holliday advised the Board only one bid was received regarding the AWOS II project. Holliday stated the procurement was next.

### **Terminal Building and T-Hangar Update**

Holliday advised the Board that State funds (Legislative Appropriations) had been secured for the project in the amount of 2.5 million. Eason briefly explained the grant was for new t-hangars, a new terminal south building and rehab the current pilots lounge for a training center.

### **RW 36 Extension Update**

Holliday advised the Board that FAA probably would not pay for the design of the project, however FAA did pay for a runaway length analysis justification study. Cobb asked what the extension length would be. Holliday stated 5,200 feet. Cobb asked if the runway would need to be widened. Holliday replied no it remain the same.

Eason explained the projects discussed were being added to the JACIP (5-year plan thru 2028) and then would be sent to FDOT.
