FMPA Solar Project Power Sales Contract

Susan Schumann – Manager of Solar Projects at FMPA

This is the only site of the three that interconnects into Duke Energy; the other two connect into OUC. Schumann stated the participants; along with FMPA and the developer met and negotiated some revised PPA terms. Schumann briefly explained the proposed changes. Schumann noted there was an eighteen month delay. Schumann noted the power sales contract between FMPA and the City of Wauchula which was signed in 2018 will not be revised and the only change would be attachment "A", which was the PPA.
