Project No. 3 - 12" Water Transmission Main from Wildcat Way Elevated Tank to U.S. 17

Project No. 4 - Finished Water Storage in Southwest Quadrant

Project No. 5 - Replace AC Water Main Along Orange Street from 1st Avenue to Wildcat Way Elevated Storage Tank

Project No. 6 - Replace Water Mains in Riverview Heights

Project No. 7 - Loop Existing Water Main along Florida Avenue from Stenstrom Road to New 12" Water Main at Altman Road (Project No. 3)

Project No. 8 - Loop Water System Along Heard Bridge/REA Roads

Project No. 9 - Replace AC Line Along Main Street from Riverview Heights to 6th Avenue (SB U.S. 17)

Project No. 10 - Replace Remaining AC and Cast Iron (CI) Lines in Southeast Quadrant

Project No. 11 - Replace Remaining AC and CI Lines in Northeast Quadrant

Project No. 12 - Replace Remaining AC and CI Lines in Southwest Quadrant

Project No. 13 - Replace Remaining AC and CI Lines in Northwest Quadrant

Project No. 14 - Water System for Municipal Airport

Project No. 15 – Water Meters

Once adopted, the City of Wauchula may avail itself of low-cost SRF funds for construction of the projects contained in the Planning Document.

Adoption of the Planning Document and the Business Plan by the City Commission is a step required to establish eligibility for the SRF program. Adoption of the Plans will in no way commit the City to construct the project, nor does it commit the City to using SRF funding or FDEP to offer SRF funding.
