Cobb motioned to approve General Pension and OPEB Financial Reports of the 1st Quarter as presented, seconded by Lambert. With no other discussion, Nadaskay called for all in favor, all responded aye. For those opposed like sign, no response. Motion carried.

Request approval of RFP 19-01 Pension Fund Attorney Services

Braxton explained RFP 19-01 Pension Fund Attorney Services to the Board. Braxton stated the only changes made were for dates and times. The current contract expires in April. Lambert motioned to approve RFP 19-01 Pension Fund Attorney Services, seconded by Cobb.
