Updates

- Peace River Park Newman stated the park was currently underwater, however the contractor
 was due there this week. Newman explained plans had been submitted and material had been
 ordered.
- R. Riveter Parking Lot Newman stated minor changes had been made and should go out to bid shortly. Albritton asked about the retail space. Newman stated they were moving forward.
- Farr Field Newman stated she had received and updated draft. Newman explained the plans were changed due to existing water lines.
- Main Street Newman explained the upcoming Main Street events.

Atchley gave a brief outline of Hurricane Ian.

Minshew gave an update on the electrical distribution system. Minshew explained the mutual aid crew from Fairhope, Alabama arrived Friday and began working immediately. Minshew discussed the restoration process and stated 85% had been restored. Minshew added Riverview Subdivision was still in question due to extensive flooding. Nadaskay commended the hard work of the line crew and the mutual aid crew. Minshew discussed the water main break behind the old Junior High. The break was due to a fallen tree. Minshew talked about garbage pick, the washout on Louisiana and sewage backups.

Braxton discussed the support to the employees and advised they were being taken care of and being fed. Braxton informed the Commission of the employees that had received damage to their homes and the ones that had lost everything.

Eason gave a public safety update. Eason stated the WWTP was inches away from devastation due to flooding. Eason explained months prior the City had submitted a mitigation grant request for a tiger dam, which was denied from FEMA because it was not a permanent structure. Eason explained Paul Siddall our regional Emergency Management Coordinator saw the projected rise of the river and submitted a mission request to the State EOC for a tiger dam. Eason stated he received a call on Tuesday that we had been approved for the tiger dam and the National Guard would be bring it that afternoon. Eason explained to the deterioration of the weather the National Guard was unable to bring the tiger dam until Thursday. Eason described the condition at the wastewater plant and the challenges they faced installing the 10,000 feet of tiger dam. Eason explained problems with Chatham Point he had received. Eason explained where the food distribution sites were. Eason discussed the incident at Valencia Gardens and explained how his

department went to the apartment complex during the hurricane and got families out of the bu	ırning
building.	

Wheeler explained she was working with the EOC and was keeping the residence updated on what was taking place within the County.

Minshew advised the Commission the WWTP was up and running.

Atchley gave a few closing remarks. Atchley discussed the food distribution, the shelter moving to the

Health Department and the visit from Governor Ron DeSantis, Ser Rubio, and Representative Greg Stuebe. Atchley thanked the Com they were hired to do.	·
